INTENDED USE OF LS-1F METER

This digital, single-zone electricity meter SIMLIC LS-1F is intended for direct measurement of the consumption of active electricity in the 1-phase installations.

Furthermore, it can be used to carry out measurements in industrial and non-commercial applications. Also, it works perfectly as a meter or sub-meter of non-distribution settlements.

The LS-1F meter indicates consumed active electricity in [kWh].


INSTALLATION

Prior to the installation, it is necessary to read the manual. This meter should be installed by a qualified person.

Prior to commencement of the installation, it is necessary to:

- make sure that the connected wires are voltage-free;
- make sure that the meter is not damaged, deformed and that no components are missing.





INSTRUCTIONS REGARDING INSTALLATION AND SAFE USE

- this device must be operated only with the use of insulated tools;
- it is prohibited to install this product in potentially explosive atmospheres or in the areas in which it will be exposed to dusts, oil mist, mould or insects;
- it is necessary to make sure that the connection wires are characterised by the appropriate cross-section and that they are properly insulated;
- prior to first start-up of the meter, it is necessary to make sure that the power cables are connected to the appropriate mounting terminals of the meter;
- touching of the meter's mounting terminals or non-insulated wires with bare hands, metal items or other conductive items creates a risk of electric shock;
- after completion of the installation, it is absolutely necessary to put on the covers of mounting terminals;
- only the qualified persons should carry out the installation, inspections and any possible repairs;
- it is prohibited for unauthorised persons without appropriate qualifications to remove the mounting covers or to interfere with the meter;
- it is necessary to protect the meter against falling and mechanical shocks.







Transmission of pulses

This meter is equipped with an additional pulse output, which allows to connect an external counting device.


Note: the pulse output should be connected in compliance with the marking. It is necessary to pay particular attention to the voltage polarity (+/-).
